NOTICE INVITING TENDER FOR SALE OF OLD PAPER.

Sealed Tender on Plain Paper is hereby invited from the bonafied interested buyers for purchasing of **old Answer Scripts, Loose sheets ,Forms ,Envelops** etc. on the basis of "**Where as it is**" lying in the damping room of Tripura Board of Secondary Education, P.N. Complex, Gurkhabasti, Agartala, West Tripura .

The Terms of Reference of this Tender are as : -

- 1) The validity of terms and conditions of the Notice inviting Tender should remain up to 31st Oct' 2023.
- 2) The **last date** for submission of tender is **25th Sept' 2023 up to 5 pm** and no tender will be received after the stipulated date and time.
- 3) Tender shall be accompanied with a consent regarding the T&C along with a "Deposit At Call / Demand Draft worth Rs: 20,000/-(Rupees twenty thousand) only from any Nationalized Bank **drawn in favour of Secretary, Tripura Board of Secondary Education, Agartala** as Earnest Money. Without Earnest Money no tender will be considered as valid and therefore out rightly will be rejected.
- 4) Rate should be quoted Per Kg basis. Highest rate quoted will be considered for acceptance. No conditional tender will be accepted.
- 5) The tender will be **opened on 26th Sept' 2023 at 3 PM** in the Board premises, if possible. The bidder or their single authorized representative may remain present at the time of opening of tender. If last day of receiving tender or the day of tender opening becomes paralysed due to any un-foreseen reason(s) / holiday then the next Govt. Working day will be the last day of receiving tender or the day of tender opening.
- 6) The waste papers will be sold and delivered on "**AS IS WHERE IS BASIS**". Interested buyer(s) having previous experience in Govt. Sector may visit to Tripura Board of Secondary Education, Gurkhabsti, Agartala on any working day during office hours with a view to inspect the items and **be satisfied about the quantity & quality** before dropping of tender. After verification of items, no complain about the quality, quantity etc. will be entertained under any circumstances later on.
- 7) The successful buyer will be bound to complete the lifting of entire quantity of the papers lying in the damping room of TBSE, Agartala as per his/her quoted rate **within fifteen days** from the date of receipt of the Work Order. Offered rate cannot be changed for any purpose / reason whatever it may be.

- 8) In case of failure to carry out the work order within the stipulated time the issued work order shall be treated as cancel and the Security Deposit shall also be forfeited automatically without assigning any reason.
- 9) The Earnest Money will also to be forfeited for violation of any terms and condition laid down in this tender notice.
- 10) After finalization of the tender, the Earnest Money shall be returned to the respective tenderer(s) except successful tenderer. In case of successful tenderer the earnest money will be treated as "**Security Deposit**" which will be refunded only on satisfactory removal of the items.
- 11) The actual weight of the waste papers can be determined during dispose of the above items. The buyer should not be left a single piece of waste papers in the Board premises. The lifting of waste papers will be made under the supervision of a Committee be constituted by the Board for the purpose.
- 12) The successful tenderer shall have to deposit the entire value of the items in advance through Bank Draft in favour of "Secretary, Tripura Board of Secondary Education"; Agartala, before taking delivery and only after receipt the Draft the weighed waste papers will be released.
- 13) No dragging, lifting, storage etc. facilities will be provided to the successful tenderer and such work are to be arranged by the tenderer himself.
- 14) The tenderer should submit his **photo Identity Card** mentioning the address in details with contact number & **Certificate of experience** in purchase of waste paper worth at least two lakh rupees at a time from any Government Institution / PSU / Autonomous Body .
- 15) The undersigned reserves the right to accept or reject any rate and even the whole process of tender without assigning any reason therefore.
